Initally three copies of ring binded thesis should be submitted by the candidate for evaluation and will become the property of University of Malakand. Text throughout the document should be in times new roman, font size 12 and line spacing 1.5. The size of the typing paper should be A4 with 1.5 inch margins to the left and 1 inch margins for the rest of three sides. All pages except the title page must be numbered at least 3/4" from the bottom of the page toward the right side. Use small Roman numerals for all preliminary pages. Begin the numbering with a small Roman numeral ii at least 3/4" from the bottom of the page toward the right side, following the title page. Use Arabic numerals beginning with the Introduction or Chapter I of the main text of the thesis, and continue with every sheet that follows, whether it be text, figures, explanation for figures or photos, tables, maps, appendices, etc., numbering pages to the end.

The final five copies of the thesis must be hard bound in maroon color for PhD and black color for MPhil. The complete title of the thesis should be printed in block, golden letters at the top of the cover. In the middle of the cover, full name of the candidate should be printed. The spine should have the surname of the scholar, the year in which the thesis is presented (Sample of the title pages are given in Annex-1)

Composition of Thesis

The thesis shall preferably contain the following parts. However; the numbers of chapters may increase or decrease by the faculties/departments/centers/institutes, in the light of the subject or nature of the study.

- 1. Abstract
- 2. Introduction
- 3. Experimental / Material and Methods
- 4. Results and Discussions

- 5. Conclusion
- 6. References

Subdivision - numbered sections

Thesis should be clearly divided into defined and numbered sections. Subsections should be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract will not included in section numbering). Use this numbering also for internal cross-referencing: do not just refer to 'the text'. Any subsection may be given a brief heading. Each heading should appear on its own separate line.

Abstract

Abstract should be concise and factual. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the thesis, so it must be able to stand alone. For this reason, references should be avoided, but if essential, they must be cited in full, without reference to the reference list. Non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.

Introduction

Introduction should be arranged by each scholar as per his/her Departmental criterion. Where the scholar will state the objectives of the work and provide an adequate background, adding a detailed literature review as a separate subsection. References should clearly be cited in the text following proper sequence and the scholar is supposed to arrange them at the end of his/her thesis. Indicate references by number(s) in brackets in line with the text. The actual authors can be referred to, but the reference number(s) must always be given.

Experimental or Material and Methods

Provide sufficient detail to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described.

Results and Discussions

There should be combined Results and Discussion section. Results should be clear and concise. And discussion should explore the significance of the results of the work. Avoid extensive citations and discussion of unpublished literature.

Conclusions

The main conclusions of the study may be presented in a conclusions section, which may stand alone or form a subsection of Results and Discussion section.

References

For references should contain all authors, title of the document, name of the publishing company/Journal, volume number, issue number, pagination and year in which it appears. Literature should include recent references as much as possible. Specimen references are given below.
