**Guide Lines:**

1. The students should make sure that concerned supervisor(s) has checked the manuscript.
2. The students will submit first page of the Research paper in hard copy along with the application form.
3. The Hard & soft copies should be same.
4. Details of the research paper will be uploaded to QEC database via [www.uom](http://www.uom.edu.pk).
5. QEC office will check through Anti-Plagiarism software “Turnitin” in “Standard Paper Repository” for plagiarism i.e. the Synopsis/ dissertation / manuscript will submitted to HEC Repository Database.
6. As QEC Office executes different functions, so Anti-Plagiarism Test Certificate will be issued within one week time.
7. **As per HEC criteria, the similarity index limit is  $\leq 19\%$ .**
8. If the whole document showed similarity/ matching Index more than 19 % then the case will be submitted to Plagiarism standing committee.
9. Originality/Similarity reports generated by the Turnitin provide clues in form of text matches, Proverbs, Universal Truths, phrases etc.
10. Originality report will show similarities from three major sources: internet, periodicals and student repository.
11. The similarities in the document may contain matches with author’s previous work and if the scholar wants to exclude this previous work then he will submit an application duly verified by supervisor/co-supervisor and countersigned by chairman of the department to Director QEC. The Director QEC has the authority to reject/exclude the previous work of the applicant either directly or through committee.
