**Guide Lines:**

1. Scholars/Students must make sure that the submitting document is in approved documenting style and is free of plagiarism.
2. The students should make sure that concerned supervisor(s) has checked the Synopsis in Turnitin software in “No- Repository” form.
3. **The single source Similarity should be less than 5%.**
4. The students will submit one hard copy of Turnitin Checked (Synopsis Hard copy having **Highlighted Similarities and similarity index** report).
5. The students will submit one soft copy to QEC office in **MS word Format** along with the application form.
6. The Hard & soft copies should be same and identical.
7. Incomplete form will not be entertained and QEC will not be responsible for any delay.
8. Soft copies of the same signed document shall be emailed to [turnitin.qec@uom.edu.pk](mailto:turnitin.qec@uom.edu.pk) by **Supervisor**, in case of any change QEC shall not be held responsible.
9. QEC office will check the document through “Turnitin” in “Standard Paper Non Repository” for Similarity / plagiarism i.e. the Synopsis will submitted to HEC Non Repository Database.
10. As QEC Office executes different functions, so application form should be submitted two weeks before the issuance of Report. No Report/certificate will be issued on Urgent basis.
11. **As per HEC criteria, the Similarity Index limit is  $\leq 19\%$ .**
12. Originality/Similarity reports generated by the Turnitin provide clues in form of text matches, Proverbs, Universal Truths, phrases etc.
13. Originality report will show similarities from three major sources: internet, periodicals and student repository.
14. Similarity index is based on percentage of matched text out of total number of words in the document.
15. Instructor/Faculty member has to verify each and every similarity index for potential clue of plagiarism.
16. Bibliography and quoted material may be excluded after verifying. It is important to note that too much quoted material is not desired as per policy.
17. Full paragraph should **NOT** be similar in Originality report with internet, periodicals and student repository etc.
18. In case of any conflict the decision of Director QEC will be final.
